### **AFGE | Election and Nominations Notice**

Representation in the AFGE National Convention shall be one vote for each member and shall be based on the average number of paid members for the 12-month period May 1 through April 30. "Member" is defined to be one for whom per capita tax shall have been paid to the Federation.

### **Election Committee & Election Procedures - AFGE Local 926**

The AFGE Local 1012 Bylaws require that the local elect an election committee at a regular meeting prior to the election. (Appendix B, Election by Manual Ballot, No. 2.) While the president may appoint the membership of most committees in consultation with the executive board, the president may not appoint the election committee.

### **RUN-OFF Election-DEADLINE 12/31/2019 | AFGE LOCAL 1395**

Every bona fide candidate shall have the right, once within 30 days prior to an election of a labor organization in which he is a candidate, to inspect a list containing the names and last known addresses of all members of the labor organization who are subject to a collective bargaining agreement requiring membership therein as a condition of employment, which list shall be maintained and kept at the principal office of such labor organization by a designated official thereof.
